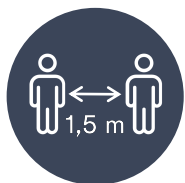
Our teams are happy to welcome you. We thank you for respecting the specific measures put in place at reception and in common areas:

Safety measures

To reduce health risks, we thank you for respecting the safety measures:

It is recommended to limit any meeting in private spaces to a maximum of 10 people, in the event that these people do not cohabit, even if the safety distance can be guaranteed.

Mandatory use of masks.

1. All persons six years of age and over are required to wear a mask:

a) On public roads, in outdoor spaces and in any enclosed space for public use, or open to the public, regardless of maintaining the interpersonal safety distance of at least 1.5 meters.

b) In establishments and catering services, including bars and cafes, the obligation to use the mask is suspended only when consuming food or drink.

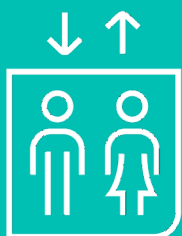
c) Correct use of the mask is mandatory. The nose and mouth should be completely covered. The mask should also be properly fitted to the nose and chin to prevent the expulsion of respiratory secretions into the environment.

Smoking, tobacco inhalation devices, water pipes, cachimbas, hookahs or the like are not allowed on public roads and outdoor spaces, since it will not be possible to guarantee the maintenance of "an interpersonal safety distance of 2 meters.

The use of tobacco inhalation devices, water pipes, cachimbas, shishas or the like in all places of recreation, reception, catering and any other type of establishment open to the public is prohibited.

Cleaning is reinforced and the contact points are disinfected regularly with a virucidal product.

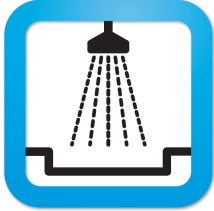

Pool safety measures



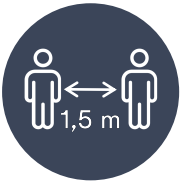
Mandatory shower and footbath.
